#### From the Editor

TGIO (Thank God it's over). This year's monthly competition changes seem to be finally settled. I can now report that, while keeping our two competition categories, our members also voted (near-unanimously) to go back to Poly's stated goals of "promoting all subjects and forms of image creation." They approved Dan's proposal, and removed all the artificial limits that existed in 2017 about the tools and methods used to create our images.

Our two redefined categories focus only on the final image. Simple summaries of their requirements are listed below.

**Realistic (R)** – if it looks real, it belongs in this category.

Altered Reality (AR) – If anything has been used so that the image or any of its elements don't look real, it belongs in this category. Also, this category is named to emphasize that it further applies Poly's basic requirement that all of our competition images originate as our own (real) photographs.

I would also like to repeat something I said in last month's editorial. The "one verses two categories" controversy seemed to be pretty contentious and devisive for a while. But now we've had our vote and come to a consensus. We've also simplified our definitions for the categories. We need to remind ourselves that "the vote wasn't personal," and unite again to make Poly a better club.

Our **featured photographer** this month is **Pat Michalowski.** Pat shows us that his favorite images are a type that many of us are not bold enough to do. He likes to do "*street photography*." His interesting pictures tell really effective stories about people. Seeing them could encourage some of us to try this ourselves. Thanks, Pat.

Finally, I've been pondering (always a dangerous thing to do) about how computers are getting smarter and more capable and can help our artistic efforts. With my background

in technology, I've always liked electronics and computers and AI and digital photography and robots and . . . Also, as I have matured, all that has been tempered and modified by experience with Art (mostly photographic art).

With my combined experience and outlook, I never imagined that I could possibly say this, but now – **Technology has gone too far!!!** 

I recently read an article about a new camera that was controlled by an AI-based computer. Google is developing a camera called "Clips." As part of this effort, they have hired some professional photographers to train the "Google Clips" AI when (and when not) to take a picture.

Their team includes a documentary filmaker, a photojournalist, and a fine art photographer. They inputed content consisting of a large number of images, and said, "What makes a memorable moment?"

They then trained the software using consistent examples to teach it specific concepts about good photography – composition, color, light, focus, etc. They also used these types of examples to teach the computer what pictures not to take.

To be fair, the Google design is aimed at a wearable device that could be used to document our lives (automatically). But it's easy to imagine future growth and developments leading to totally-automated street photography robots (and more).

We've already seen smart phone apps that offer compositional assistance when we are using them to take a picture. But we're talking about a camera here that takes the picture itself!

I have never believed the doomsayers who have worried that robots and artifical intelligence computers will "take over the world." But trying to take over photography is just too much to ignore.

But on the other hand, maybe having some AI-Computer judges could be an improvement.

## Featured Photographer of the Month . . . . Pat Michalowski

I have gathered together six images that represent what I enjoy most about photography. Most photographers are looking for that unique image, the image they can own, no matter what their special area of interest. Although I too look for unique images in whatever I am shooting, (landscape, portrait, nature, architecture, etc.), I find that Street Photography/Portraiture provides me with the greatest opportunity to reach my goal.

The serendipitous nature of Street Photography implies that you are not looking for a specific image, only images that tell a story. Others may not see or find what you do, increasing the odds that your image is indeed unique. I have chosen to include only images that I would classify as Street Photography, it is what I enjoy the most about my hobby.



"Bubble Man" (On the cover)- The bubble man was entertaining a crowd in plaza in Aix de Provence France. I have tried to show him as the man behind the bubbles. I hope that others will view this image and wonder what has driven him to spend countless hours perfecting this art of bubble making. His masterpieces always disappear within seconds and he begins anew, not knowing what he will create and unable to preserve it for others to see, only to start again and again and again.

"Boy in a Bubble" - I saw this young man bouncing about aimlessly inside a large ball at a street fair in Santee. He seems to be entering another dimension. I can only assume that is how he felt as he moved around uncontrollably.



"New Mexico Native Dancer" - On the streets of Old Town, Albuquerque, NM, this dancer performed for the crowd. You can see in his face, his commitment to his heritage.



"Lonely Street Performers" - I was drawn to this backstreet in the Old Town section of Valencia, Spain by the melodic strumming of guitars that pushed the notes around the corner of this walkway. The two artists, perhaps preparing to perform for the main street crowds, seem to fit cozily and symbolically in the curve of the sheet music notation created by the afternoon shadows.



"Oaxacn Street Vendor" - The lines in her face, the crook in her neck depict a tough life. A life of long hours selling her wares for a few pesos each at the plaza in Oaxaca, Mexico.



"Dinner in a Bag" - This woman was shot on the streets of Teotitlan, Mexico. She is waiting for a taxi to take her and her bags of live chickens home to prepare the evening meal. Some of these birds will likely be kept in a coop to produce eggs for the family. As she waits, she seems to be contemplating visiting the museum at some point as suggested by the signage.

### Full Poly Bylaw Changes to Competition Sections Articles VII and VIII, Approved at the Poly meeting on January 6, 2018 By Dan Palermo

#### POLY PHOTO CAMERA CLUB BYLAWS

(Revised January 2018)

#### **ARTICLE XII – MONTHLY COMPETITION**

By virtue of submitting an entry, the photographer certifies the work to be his/her own and that the image began from the member's camera. Images in each category shall be judged without consideration of subject matter, as long as the subject matter is appropriate to its Categorical definition.

#### Section 1:

A competition shall be held at the first meeting of each month. Each member may enter up to two digital images. Members may enter one image in each of the two categories described below, or two images in a single category. Images entered in either category are allowed to be modified without restriction in a category-appropriate manner, as long as the primary subject matter was photographed by the maker.

#### **REALISTIC Category**:

Images entered in this category must only contain subjects and scenes that do, or look like they could, exist in the real-world. In addition, images that could have been taken with a film camera with a minimal amount of darkroom-type corrections (i.e., exposure correction, minimal dodging and burning, etc.) are allowed. The Realistic category includes images that use the following techniques; black & white, multi-toned, infrared, black-light, stitched-panoramas, HDR, multiple-exposures, composites, cloning, adding realistic textures, along with others, as long as the goal is to make the image appear realistic.

**Important:** Image titles must begin with the letter "**R**" followed by a space in order to be entered into the Realistic category (example: *R Winter Storm by Ansel Adams*).

#### **ALTERED-REALITY Category:**

Images entered in this category may contain some or all subjects, elements, and/or scenes that could not or do not exist in the real-world, as shown. The Altered-Reality category includes photographically-based styles such as; photo-illustration, fantasy, enhanced or altered reality, imaginative photo-art, along with other types of non-realistic techniques, as long as the original image began from the maker's camera.

**Important:** Image titles must begin with the letter "**AR**" followed by a space in order to be entered in the Altered-Reality category (example: *AR Martian Invasion by Orson Welles*). If an image title does not begin with the letters "**R**" or "**AR**" it will be entered into the Altered-Reality Category by default.

#### Section 2:

The judge shall not be a club member. In an emergency, a qualified member may act as judge, provided that such a member does not enter that month's competition. Any member acting as emergency judge shall be allowed one makeup entry consisting of two images at a future competition during the year. The competition date may be changed at the discretion of the Executive Board as long as the membership is notified of the change at least 30 days prior to the

originally scheduled competition date. The judge shall be instructed to critique each image and offer constructive comments as deemed appropriate.

The judge shall then rate each image on a scale of 5 to 9 points according to the following guidelines:

- A. 5 points = some technical deficiencies; not showing any particular skill of the photographer
- B. 6 points = average, some showing of the photographer's use of good technique and recognition of an interesting subject
- C. 7 points = fairly strong in technique and interesting; worthy of being accepted for exhibition.
- D. 8 points = well balanced; strong in interest, composition and technique and impact.
- E. 9 points = exceptionally good; high in interest, composition, technique and impact.

It must be recognized that an image may be so strong in some areas that it overrides weakness in some other area. Images scoring a 7 or greater shall be considered acceptances. Images scoring less than 7 may be re-entered at a later date.

#### Section 3:

Judges shall be instructed to select First, Second, and Third place winners at each monthly competition in each category as follows:

- A. First place shall be selected from those images scoring a 9.
- B. If no images scored 9, the selection shall be made from those scoring 8.
- C. If no images scored 9 or 8, the selection shall be made from those scoring 7.
- D. Second and Third place shall be selected from those images remaining from the 9's first, then the 8's, then the 7's as applicable.

#### Section 4:

Points received by a maker shall be recorded and counted toward the year-end high-points award for each category. A member may participate in any or all of the monthly competitions and yet elect not to participate and not have his/her scores totaled and posted in the competition score sheet for yearly "High Points Awards." Those members may still enter images into the year-end competition as detailed in Article XIII – Year End Competition.

#### Section 5:

Once an exhibited image has been accepted in Club competition (by receiving a score of seven points or greater), it, or a near duplicate taken at the same time, cannot be entered in any future monthly competition in any category. A similar image that is created from the same original digital file, but is clearly different and not a near duplicate may be entered in a future competition.

#### Section 6:

No make-ups shall be allowed for any missed monthly competitions. Yearly High-Points competition scores shall be determined by totaling the highest nine of the eleven possible monthly scores. If a member participates in less than nine monthly competitions per year, his/her high-points competition score will be calculated by using the total of the competitions in which he/she actually participated.

#### Section 7:

A monthly "Project" competition shall also be held at the discretion of the members.

#### **ARTICLE XIII – YEAR-END COMPETITION**

#### Section 1:

Entries in the year-end competition shall be chosen from accepted images in monthly competitions from that competition year. Each member shall choose eight of his or her images from those that have received a score of seven or higher, regardless of category. Submitted images may be improved versions of the original accepted images from the monthly competitions, as long as they are clearly the same image. Improvements may be based on the photographer's judgment or the judge's comments. The President or the Competition Chairperson shall make arrangements deemed appropriate to judge these images. The judges shall select First, Second and Third place image winners in each of the two Categories, plus approximately ten percent of the entries in each Category as Honorable Mentions. First, Second and Third place winners shall receive inscribed medals. Honorable Mentions shall receive ribbons.

#### Section 2:

High-points awards will be determined by totaling the points accumulated from the monthly competitions as defined in Article XII, Section 4. First, Second, and Third place High-Points Awards will be given separately, at Year-End, to winners of the Realistic category and the Altered-Reality category. In addition, First, Second, and Third place High-Points Awards will be given to winners of the Combined-Category, created at Year-End for those who have entered at least 6 of a possible 22 images in both the Realistic and Altered-Reality categories during the competition year. If a winner qualifies for High-Points Awards in more than one category (i.e., such as Awards in both Altered-Reality and Combined-Category), only the highest Award will be given regardless of which category it is in. In the event that a winner earns the same High-Points Award in multiple Categories (e.g., two Third Places), only one Award will be given using the following category hierarchy: (1) Realistic, (2) Altered-Reality, and lastly (3) the Combined-Category.

#### Section 3:

The names of First Place High-Points winners of the Realistic, Altered-Reality, Combined categories shall be inscribed on the High-Points Perpetual Trophy. An inscribed medal shall be awarded to all First Place winners, along with Second and Third place runners-up in each Category. In the event of ties for First Place in any Category, all First-Place names shall be engraved on the High Points Trophy and receive inscribed medals.

Let's look at the competition scores from January's meeting. We had 51 entries in CAT1 and 9 entries in CAT2. After the vote to make changes in the definitions for both categories and change the names of the categories to Realistic and Altered Reality, we proceeded with the competition. I haven't heard how we're going to title our entries. (*ed note – it's in this issue*.)

In the Realistic Category we had 17 sevens, 23 eights, and 11 nines. In the Altered Reality category we had 9 entries. There were no 7's, but we did have 3 eights and 6 nines. Looking at both categories we had a total of 60 images enter in the competition.

Did you ever want to know how many different DSLR camera models Nikon makes? Neither did I, but I checked it anyway. (You Canon people can let me


know what their numbers are for next month.)

Nikon has 20 different DSLR's on the market right now. Entry levels begin with the D3300 selling at \$399.95 and for the rich and famous, the price for the D5 Anniversary Edition is \$7999.95. The other 18 models fall somewhere in between

His first work as a photographer was in the US Army. Following his military service, he worked at KOLD-TV in Tucson, AZ and documented Mercury, Apollo, and other aerospace projects for Ryan Aeronautical Company in San Diego, CA.

From koalas and giant pandas to bottlenose dolphins and seahorses, his images have appeared in national and international newspapers and magazines, in coffee table and children's books, and on posters, note cards, calendars and CD's.


# **Tucson Photo Adventure**
